Part C Vulnerable Sector Search Authorization

This area is to be used by a person applying for a position with a person or organization responsible for the well-being of one or more *children or **vulnerable persons, if the position is a position of authority or trust relative to those children or vulnerable persons and the applicant wishes to consent to a search in a criminal conviction records to determine if the applicant has been convicted of a sexual offence listed in the schedule to the *Criminal Records Act* has been pardoned/record suspension. *Children as defined by the *Criminal Records Act* means persons who are less than 18 years of age. **Vulnerable persons, as defined by the *Criminal Records Act* means persons who, because of their age, a disability, or other circumstances, whether temporary or permanent, are in a position of dependence on others or are otherwise at a greater risk than the general population of being harmed by persons in a position of authority or trust relative to them.

I hereby request and consent to a search being made by the automated criminal records retrieval system maintained by the Royal Canadian Mounted Police to determine if I have been convicted of, and have been granted a pardon/record suspension for any of the sexual offences that are listed in the schedule of the *Criminal Records Act*. I understand that, as a result of giving this consent, if I am suspected of being the person named in a criminal record for one of the sexual offences listed in the schedule to the *Criminal Records Act* in respect of which a pardon was granted or issued, that record may be provided by the Commissioner of the Royal Canadian Mounted Police to the Solicitor General of Canada, who may then disclose all or part of the information contained in that record to a police force or other authorized body. The police or authorized body will then disclose that information to me. If I further consent in writing, to disclosure of that information to the person or organization referred to above that requested the verification, that information will be disclosed to that person or organization.
